- 1. If the student resigns during the residency tenure of the course he/she will be liable to pay Rs.10 Lakhs + applicable GST & fees paid by the student till date will be forfeited.
- 2. After completion of MD Course, he/she has to serve for 1 year at Dr B Borooah Cancer Institute including any of the outreach units of TMC Mumbai, failing which he/she will be liable to pay Rs.25 Lakhs + applicable GST

Hereby jointly and severally bind ourselves and our respective heirs executors and administrators to pay to Dr. B Borooah Cancer Institute (hereinafter referred as the "BBCI"), its successors and assignees, on demand the sum of Rs. 25,00,000/- / Rs. 10,00,000/- (Rupees Twenty Five Lakhs or Rupees Ten Lakhs) + applicable GST as the case may be and as hereinafter contained together with interest thereon from the date of demand till the date of payment, in the event of breach of the conditions by the said PG student as set out below.

(3) WHEREAS, the PG student has applied to the Centre against open advertisement for admission to the PG degree in MD course conducted by the Dr. B Borooah Cancer Institute for imparting training in MD degree (hereinafter referred to as PG course).

The said PG student has agreed to execute this bond with two sureties aforesaid and with such conditions as herein under written.

Now the conditions to be observed and complied with by the said PG student and their sureties are as under:

- The PG student has voluntarily accepted admission PG to the course (DOJ). The PG student has clearly understood that he will be required to sign a bond for completion of the residency tenure for the period of 3 years and binds himself that he will complete the course, failing which he would be bound to pay Rs. 10,00,000/- (Rupees Ten Lakhs) + applicable GST to the Dr. B Borooah Cancer Institute forthwith on demand by the Dr. B Borooah Cancer Institute together with the interest there on from the date of default at the rate prescribed of Government loans and prevailing on the date of demand or if payment is made in the country other than India, the equivalent amount of the currency of that country converted at the official rate of exchange between that country and India. This condition shall however, not be applicable to the candidate who is resigning before the final round of selection conducted by MCC/ DME Assam for Dr. B. Borooah Cancer Institute on prescribed dates decided by these Authorities.
- b) The PG student clearly understands that in the event the said PG student continues the course for the entire duration of 3 years and on his successful completion he is required to serve for a minimum period of one year at Dr. B Borooah Cancer Institute or any outreach units supported by Tata Memorial Centre, Mumbai and he will be paid consolidated stipend as may be prescribed at that point of time and in any case it will not be less than the consolidated stipend paid to him / her on the date of qualifying in the said degree. The PG student further binds himself along with the sureties that in the event he / she fails to serve as stated herein before at the Dr. B Borooah Cancer Institute or any outreach units supported by Tata Memorial Centre, Mumbai as aforesaid for the said minimum period of one year, he will be liable to pay the sum of Rs. 25,00,000/- (Rupees Twenty Five Lakhs) + applicable GST as a breach of condition. Student will not be allowed to leave during Service Bond period for any reason. Students will be allowed to appear for NEET-SS & if selected, can join the Govt. Medical College / Hospital only for further studies and complete remaining bond period after completion of their Higher Studies. Students on Bond if selected, for State or Central Govt. service then they have to take prior permission in writing for joining the service after completion of bond.

do hereby jointly and severally covena	nt with the BBCI that	if the said PG	student make
default in payment of the sum of Rs	. 25,00,000/- (Rupees	Twenty Five	Lakhs only)+

applicable GST as mentioned above or any part thereof, together with interest theron from the date of demand at Government rates for the time being in force on Government loans, the sureties shall on demand and without murmur pay to BBCI the said sum of Rs. 25,00,000/-(Rupees Twenty Five Lakhs only) + applicable GST together with interest thereon from the date of default at the rate levied for Government loan and prevailing on the date of demand and that the liability of sureties hereunder shall not in any way be affected by any time waiver or indulgence of any nature of any kind whatsoever given made or shown by BBCI to or in favour of the said PG students. The sureties hereby agree that to all intents and purposes the liability of the sureties for the payment of all the sum of money under this agreement shall be deemed that of the principal parties each of both the sureties, jointly and severally.

- 5) Notwithstanding anything herein contained, it shall be lawful for the BBCI to terminate the tenure of the Residency of the course, if his / her progress has been found to be Unsatisfactory by the BBCI or any violations of the rules / regulations, as applicable or for the other reason of which the BBCI shall be sole judge, and in that event the said amount of Rs. 10,00,000/- (Rupees Ten Lakhs Only) + applicable GST as contained in Para 4 above shall become payable by said P.G. Students / sureties immediately and the said PG student shall be bound to pay the same and if he / she falls to do so, the sureties shall be jointly and severally responsible to pay the same to BBCI on demand.
- 6) It is expressly understood by the said PG Students and the sureties herein that that the Dr. B Borooah Cancer Institute shall be entitled to recover the said sum of Rs. 25,00,000/- / Rs. 10,00,000/- +applicable GST as the case may being the event of default of their payment on demand and that Dr. B Borooah Cancer Institute shall be entitled to initiate civil / criminal proceedings as may be required at the cost, risk and consequences of the said PG student and the sureties thereon.

This agreement shall in all respects be governed by the laws of India for the time being in force and the courts in Guwahati shall have exclusive jurisdiction to try the dispute and adjudicate between the parties.
